## **QUALIFICATIONS**

- The qualifying equipment must be installed in a Minnesota commercial building served with natural gas from Great Plains Natural Gas Co. (Great Plains).
- The Commercial Steam Boiler rebate applies only to the purchase and installation of new equipment, used equipment does not qualify.
- Rebates are available only to commercial space heating steam boilers. Steam Boilers used for industrial processes do not qualify under this rebate, but may be applied for under Great Plains' Commercial Custom Project rebate.
- Low Pressure Boilers are all steam boilers 15 PSI or less; High Pressure steam boilers are all boilers over 15 PSI
- Great Plains uses AHRI (Air Conditioning, Heating and Refrigeration Institute) listings to determine the efficiency of heating equipment. You can access this information at <a href="http://www.ahridirectory.org">http://www.ahridirectory.org</a>
- If equipment is not rate by AHRI please enclose the manufacturer's combustion efficiency documentation.
- Heating contractors are not eligible to receive their customer's rebate.
- Equipment installed under warranty replacement does not qualify for the rebate.
- Great Plains will not issue rebates for more than 100% of the cost of the service, equipment or energy saving measure.

## **APPLICATION REQUIREMENTS**

- > The rebate application form must be submitted within 90 days of installation date or postmarked by December 31 of the plan year whichever comes first.
- Application must be completely filled out with purchaser information, equipment information (including brand, complete model number, serial number, installation date and AFUE rating) and contractor information.
- Great Plains is unable to accept applications that do not include all this information.
- > It is the responsibility of the contractor and purchaser to ensure that the installed equipment qualifies for the rebate.
- If the equipment does not qualify, no rebate will be paid.

## **REBATE DETAILS**

Rebate qualifications and amounts are subject to change. Rebate funds are limited. Completed rebate forms will be processed in the order in which they are received. Great Plains ECO rebate programs may be cancelled or changed at any time.

The rebate application form must be postmarked by December 31 of the plan year for the rebate to be processed. Rebates will not be paid if funds are depleted prior to December 31.

Rebate amounts will be issued for equipment installed between January 1 and December 31 of the plan year only. Great Plains issues rebates in the form of checks, not utility bill credits. Great Plains is not responsible if the dealer does not provide accurate information about the amount of rebate or equipment eligibility. Allow 4-6 weeks for rebate processing.
